### TERMS & CONDITIONS

1. The work should be executed as per CPWD specifications and as per directions of Engineer-In-Charge.
2. All T & P shall be arranged by the Contractor.
3. *Nothing shall be paid extra on A/C of cartage, Octroi etc.*
  
4. The materials to be used must be got approved from the Engineer-in-charge before installation/use.
5. The agency shall be solely responsible for any damage/loss to the Board's Property / equipment's.
6. The agency shall take all precautionary measures for safety of his workers during Performance of the work.
7. The work is to be completed within a period of 15 days.
8. The work shall not be discontinued at any cost.
9. The workmanship must be excellent. In case of poor workmanship, the Board shall be free to cancel the contract.
10. The agency shall ensure that the wages to the workmen are paid according to minimum wages prescribed by the Govt. of N.C.T. Delhi.
11. *Necessary statutory deductions will be made as applicable.*
12. *Debarred agency /or individual shall not be permitted to participate in the tendering process.*
13. *Any individual who has been debarred is not permitted to take part in any negotiations or represent an agency even if he holds a power of attorney on the agencies behalf. Any agency engaging debarred persons is also liable to debarring.*

14. *The experience of agencies shall be taken into account rather than individuals incorporated with the agencies which does not include proprietorship.*

15. *The contractor will be fully responsible during excavation of work if any damage done at site during excavation of work the same shall be made good free of cost with in quoted rates.*

16. *The validity of the quotation is 60 days from the date of opening of the sealed quotations.*

17. *The rates in the quotations should be inclusive of all taxes/levies and DDA will not pay/reimburse any Tax/levy whatsoever.*

18. *Only those specialize agencies are eligible who has done three similar type work in Govt. Department PSU in the last two years. Necessary document shall be attached otherwise quotation may not be entertained.*

19. *Payment will be made after the entire satisfaction.*
