8. The commercial plywood shall be of kitply/national/duro/ISI.
9. The door closer shall be of amar/godrej/everite.
10. The flush door shutters shall be Diamond/Swati/Bhutan/Sitapur/ISI.
11. The mortise lock shall be of godrej/Harrison/Link.
12. Toughened glass of modi/asahi/saint gobain.
