## TENDER DOCUMENT

### **Tender for Annual Maintenance Contract (AMC) of Computers at CBSE**

Sealed quotations are invited from qualified service providers for providing Annual Maintenance Contract (AMC) of Computers at CBSE.

The scope of work and terms and conditions of the contract including format of bids etc. are enclosed with this tender as per following details-

- b) Eligibility criteria with terms & conditions at **Annexure B**.
- c) Format of technical bid at **Annexure C**.
- d) Format of Financial Bids at **Annexure D**.
- e) List of all the equipments at **Annexure E**.

The Bidders can seek clarification with respect to the bidding conditions/bidding process before submission of tender.

The entire document including its annexure ,except financial bid in Annexure D, will be part of the technical bid along with the EMD and all other requisite documents. The technical bid (including entire tender documents and its annexure except financial bid) is required to be signed on each and every page by the authorised signatory, failing which the bid will be treated as technically disqualified. Bidders shall go through the entire tender documents carefully before submitting the tenders.

The technical bid (**Annexure C**) alongwith other documents and financial bid (**Annexure D**) should be kept in two separate envelopes and each superscribed as “Technical Bid” and “Financial Bid” respectively and sealed separately. Both these envelopes should be put in a bigger envelope superscribed as “**Annual Maintenance Contract of Computers at CBSE**” and sealed and addressed to the Deputy Secretary (A&F) CBSE, Shiksha Sadan, 17 Rouse Avenue, New Delhi.

The sealed quotation may be deposited or sent through speed post/ registered post/ ordinary post/ courier latest by **22.08.16** till **2:00 PM**. The bids shall be opened on same day i.e **22.08.16** at **3:00 PM**. The tender received after stipulated time and date shall not be entertained and shall be summarily rejected. The conditional tenders are not to be accepted and shall be rejected without assigning any reason.

The financial bids of technically qualified bidders will be opened in the presence of their representatives. The company should have experience of providing annual maintenance of

similar nature for at least two years with Government Departments/ Public Undertakings/ Autonomous Bodies/ Corporate / Private/ in Delhi and the total annual turnover value of which should not be less than Rs.1,00,000/-. Details of work done in the last three financial years along with the names and addresses of the clients along with the work award contract should be provided.

Technical bid should contain all the document listed in **Annexure C** in the prescribed format. The amount that the service provider quotes in **Annexure D** format for providing services described in the “Scope of work” categorized as **Annexure A**, taking into account all the equipment installed in the Institute, listed as **Annexure E**.

#### **Earnest Money Deposit**

The bidders are required to deposit a sum of Rs. 20,000/-(Rupees twenty thousand only) **along with their technical bid** in the form of A/c payee Demand Draft, favouring “Secretary,CBSE,Delhi” towards earnest money. In case of unsuccessful bidders, the same will be refunded to them within one month.

#### **Mode of payment**

The payment of maintenance charges will be payable by the Board after executing of agreement on a non-Judicial stamp paper of Rs. 100/- and signed by both the parties.

#### **Performance Guarantee Deposit**

Successful Bidders have to deposit performance security of ₹ 50,000/-(Rupees fifty thousand only) in the form of demand draft or bank guarantee favouring in the name of ‘ Secretary, CBSE’. The performance guarantee shall be valid for 90 days beyond contract period.

Performance security shall be returned only after the expiring of the contract period successfully and to the satisfaction of the competent authority. CBSE has the right to forfeit the performance guarantee in case of non-cooperation, disobedience of the instruction, non attending of complaints within time or date, any damage to equipment on the part of the bidder or employee of the bidder or for any other breach of contract.

### **Scope of Work**

#### **Work Details**

Comprehensive Onsite Annual Maintenance Contract for maintenance of Computers and other equipments in CBSE. The details of the equipment in CBSE, Delhi are given in **Annexure-E**.

Deployment of full time qualified Computer personnel for corrective and remedial maintenance services from 09.30 hrs. to 18.00 hrs. (Monday to Saturday)

#### **Duration and Timings**

- The agreement shall come into effect from the day so specified in the work order and shall expire automatically after 12 (Twelve) months from the said date, unless otherwise terminated.
- It is however open to CBSE to extend the tenure of this agreement upto 3 years on the basis of the satisfactory performance of services.

#### **Mode of Operation**

- The firm shall provide unscheduled, on-call corrective remedial maintenance service from 9.30 AM to 6.00 PM from Monday to Saturday to keep the machines in good working order.
- The service consists of remedial and corrective maintenance and includes carrying out of the necessary repairs and fittings of replacement parts and to ensure net connectivity in the computer system.

The Successful bidder shall be held responsible for proper conduct, and safety of computer personnel engaged by him. The personnel so engaged by the Contractor, shall be under his employment and disciplinary jurisdiction. However they shall be subject to the overall discipline of CBSE. Police verification of the operator will be obtained by the service provider before deploying them.

The personnel engaged by the successful bidder should be polite with pleasing manners, co-operative, disciplined and should not smoke or be drunk while on duty and inside the campus premises of CBSE. The Contractor will be held responsible for the same, and under no circumstances CBSE will be responsible for any obligations / liabilities.

**Compliance of Statutory Requirements:** The successful bidder shall ensure compliance to All statutory requirements as applicable during the tenure of the Contract. He shall ensure

compliance of all the provisions of various Labor Enactments viz. The Minimum Wages Act 1948, The Payment of Wages Act 1936, The Workmen's Compensation Act 1923, The Employees Provident Fund & Miscellaneous Act 1952, and any other Labor Enactments as may be applicable from time to time.

**Deduction of Taxes:** - All provisions of the Income Tax as per Rules shall be complied with strictly.

### **Eligibility Criteria & Terms and Conditions**

- a) Quote the separate rates for deployment of full time qualified Computer personnel for corrective and remedial maintenance service from 09.30 hrs. to 18.00 hrs. (Monday to Saturday).
- b) The computer personnel should have at least 2 years of experience in a similar capacity.
- c) The computer personnel should be able to layout new LAN wires when required.
- d) LAN troubleshooting skills are also required.
- e) Quote the separate rates for Comprehensive maintenance including replacement of unserviceable parts.
- f) This contract is comprehensive in nature and will cover replacement of all defective parts/equipments such as motherboards, hard disks, picture tubes, DVD drives/writers, and keyboards, printer's mechanical parts including print heads till they are repairable excluding stationery, ribbons, floppies and cartridge-tapes.
- g) Complaints shall be attended on the same day. Replacement and/or repair of the hardware equipment shall be carried out within 24 hours of registering the complaints. It is the whole & sole responsibility of the firm to repairs/replacement of equipment & stand-by computer or printer failing which a penalty of 2-5 % shall be imposed on the quarterly payment to the firm.
- h) The firm agrees to maintain the equipments specified in this Agreement in accordance with terms and conditions mentioned above.
- i) In case of unsatisfactory services, the Secretary, CBSE shall terminate the contract at any time during the prescribed period of maintenance without assigning any reason.
- j) The agencies, if they desire, may inspect the machines before quoting the rates.
- k) The rates should be quoted without Taxes and Taxes should be quoted extra.
- l) Turn over for AMC/work/sale of computers and its peripherals for last two years shall be at least Rs. 1,00,000/- per year.
- m) The firm/company having ISO certificate or Equivalent will be preferred. Only that firm/company may apply who has at least 02 years of experience in AMC of computers and its peripherals in Government Department / PSU/Ltd. Companies. The Work Orders of those Department should be attached where the firm/company, is holding AMC of computers and is peripherals.
- n) The firm/company should have experience as Authorized Service Providers for HP/HCL / LENOVO/ Compaq/ Acer/Dell/Mac Apple for 2014-2016.
- o) The firm/company shall have to clean all the PCs installed in the Academic Building, Delhi, in each quarter with blower.
- p) The firm/company shall have to recover the Data, if missed from any of the computers.

- q) The firm/company shall have to take serious concern while backup & restoration of data while providing a new computer or a stand-by computer. Also while taking back up on the stand-by computer, the firm Engineers have to ensure proper movement of Data without loss.
- r) The Secretary, CBSE reserves the right to accept or reject any or all the tender/s without assigning any reason.
- s) The contract will be for one year but may be extended up to 3 years on sole discretion of the Board and work satisfaction. The payment of maintenance charges will be payable by the Board after executing of agreement on a non-Judicial stamp paper of Rs. 100/- and signed by both the parties. In case the firm /company does not provide satisfactory services, the Secretary, CBSE can terminate the AMC at any time and no payment shall be payable for the period of unsatisfactory service and the firm will have to refund the amount of AMC to the Board. Besides the amount of EMD/ performance guarantee will also be forfeited by the Board.
- t) The Jurisdiction in legal matter will be Delhi/New Delhi.
- u) A performance guarantee deposit of Rs. 50,000/-(Rupees fifty thousand only) has to be deposited with the Board, on receipt of work orders. Deduction on unsatisfactory performance, loses will be made from this deposit which will stand forfeited in case of withdrawal of contract by the firm. Fresh performance guarantee deposit will be payable in exhaustion of original deposit.

### **Indemnity**

The company shall keep indemnified, CBSE fully against all claims, proceedings, actions, damages, legal costs, expenses and any other liabilities whatsoever arising out of the AMC. The decision of the Chairman, CBSE in this regard shall be final and binding.

### **Period of Contract:**

- The Contract shall be valid initially for a period of one year i.e. from the date of contract and extendable upto 3 years based on the performance. CBSE reserves the right to terminate the Contract awarded at any time during the currency of the Contract without assigning any reasons by giving one month's notice in advance in writing. The Successful bidder shall be required to give three month's advance notice in writing for termination of the contract, failing which the security deposit shall stand forfeited.
- Under no conditions, the service provider for his staff shall claim the benefits of CBSE Rules, Wages, Allowances and facilities etc.
- The Tender as furnished shall remain open and valid for a period of three months from the date of opening.
- CBSE shall not be responsible for delay or non-receipt of tender documents during transit by Post.
- CBSE reserves the right to reject any or all tenders without assigning any reason thereof at any stage of the process.
- Prior to commencement of the Contract, CBSE officials shall inspect office of the bidder.

### **Payment terms & conditions:**

- The payment of AMC shall be made quarterly at the end of every quarter after obtaining satisfactory performance certificate from the users. The contractor shall not



further subcontract this Comprehensive Annual Maintenance Contract (CAMC) under any circumstance to a third party/ sub contractor for the maintenance.

### **Penalty**

In the eventuality of the AMC contractor not being in a position to rectify the fault within two Working Days (48 hours) for any equipment a standby equipment of acceptable similar configuration shall be provided to CBSE by the firm. On failure to provide standby equipment, a penalty @ 1% per day per equipment of the total contract value (AMC amount) will be levied. Delay beyond 07 days in rectifying the reported problem will entitle this office to exercise the option of getting the work done from another agency and deduct such expenses from the AMC charges, in addition to penalty. Delay beyond 15 days may lead to cancellation of contract by this office.

### **Termination:**

The AMC can be terminated by giving 1 month prior notice period.

### **Arbitration:**

In case of any dispute arising under this contract the same shall be referred to the sole arbitration. The Chairman, CBSE or any person nominated by him on his behalf, shall appoint the sole arbitrator, which will be acceptable to both parties.

### **Tenderer(s) shall submit the following details/documents with tender:**

- i. Valid registration Number of the firm for the VAT / Service Tax purpose.
- ii. Audited financial statements & Income Tax Returns for the last three financial Year.
- iii. Document related to total years of experience in AMC of Computers and other peripherals (PO copies of last three years)
- iv. Form 16 A (copies) issued by the Government Organizations / reputed organization deducting TDS on AMC services provided by the firm.
- v. List of Government, reputed private organization which renewed the AMC with the firm, with copies of orders.
- vi. Signed copy of tender document along with scope, terms & conditions.

Conditional tenders shall not be accepted and shall be rejected straightway.
